

In the Name of Alla The Merciful

A Sulha Agreement Document

In the name of Alla, The Merciful, today, Saturday, February 28, 2009, a Sulha takes place in the town of Shefaram, between the Abu Ra'ed family from Shafaram, and the Family Wehebe, from Dalyat El Carmel.

Following the authorization and agreement given by the dignitaries from the Abu Ra'ed and Wehebe families to the Sulha Committee, which is made up of Sheikhs and from local dignitaries, and in the aftermath of a sorrowful event that took place on May 16, 2004, during which the woman Manal Abu Ra'ed from Shefaram was killed.

The Sulha Committee has exerted enormous, blessed efforts, gathered several meetings with both parties, each side separately, and with the assistance of the good, peace-loving people, including Sheikhs, and dignitaries from both towns, and thanks to Alla the Great, these efforts were successful, and the Sulha Committee has reached the stage where it sets the rules for reconciliation and peace between the two respectable families, based on the tribal tradition, the Sulha Committee determined the following:

- 1) Family Wehebe will pay family Abu Ra'ed Blood Money in the sum of 200,000 NIS (~ \$50,000.00 DP) to the family of the departed Manal Abu Ra'ed. This follows a gesture by the Abu Ra'ed family to the Sulha Committee, in which the family Abu Ra'ed gave up part of the Blood Money, as well as gave up the Atwa (Cease Fire Bond). We (the Sulha Committee DP), are grateful to them, and wish them all the very best.
- 2) The Blood Money given to the family Wehebe, will be allocated and registered (deposited) on the names of the daughters of the deceased, Manal Abu Ra'ed, until they reach adulthood.
- 3) Both sides will shake hands, forgive and reconcile, based on the habits and traditions of the Arabs, and the acceptable rules governing such events.
- 4) This reconciliation obliges those who are present, and those who are absent, the child, and the young and the old, the girls and the women, and all who may be in their mother's womb, and in their father's seed, on both sides (of the dispute, DP).
- 5) This Sulha takes between the two families above comes to bring an end, with the help of Alla, to all the disagreements, and the conflicts between these families, and to bring about peace, reconciliation and mutual understanding between the sides, and therefore, neither side has any claims of any kinds toward the other side.

We ask Alla to bless all of us to do good deeds, and to bless the reconciliation between the people.
