

Sulha Agreement

In the Name of Alla The Merciful

Alla Said: “Believers are brothers, therefore make peace between your brethren, for they will see Alla, and maybe he will take mercy on all of you. For right he was, Alla, the Great.”

Taking note of the killing of the late Nasser Nur Suliman, on the date of 23.7.2005, and the arrest of Mr. Tawfiq Elias Farouni.

And taking note of the intervention of the respectable Sulha Committee, to include Mr. Taha Abed El Halim, and Chaled Taha from Kafar Kana, and the gentlemen Ali Fuad Diab, and Hamid Awad Matmara, and Mr. Ahmed Jarbuni from Arabe, and the gentlemen Fathi Hatib and Abed Alla Hativ, and the priest, father Awad Awad, and Sheikh Hassan Haider from A’ebnin, and the gentlemen Farage Khnifes and Ibrahim Naum from Shefaaamer, and the Sheikh Ali Abu Sabit; it was agreed that:

- 1) When family Suliman and family Farouni partook in the Sulha (reconciliation), it is considered to be a charter with Alla, and a binding promise that the respectable conciliation comes in the place of the conflict and the hateful disagreements.
- 2) The reconciliation between the two families took place on Saturday, 21.2.2009, in A’ebnin.
- 3) Family Farouni paid, as per the decision of the respectable sulha committee, and handed the blood money over to the family of the late Nasser Nur Suliman, without declaring a value, and that as per request from the respectable family.
- 4) Both sides hereby forgo all civil and Sharia and acceptable rights, and no side will have any additional claims from the other side.
- 5) Everybody bears witness that the conciliation is binding for all the present and the absent, those in this country and abroad, those in their mother’s womb, and those in this country and abroad, those in their mother’s uterous, and those who are still sperm with their father.

Alla said: “cooperate fro the sake of good and the faithful, and do not cooperate in search of sin and hostility.”Alla the magnificent is right.
